

Community Waste Reference Group - Expressions of Interest

Invitation

Mount Alexander Shire Council (MASC) is seeking expressions of interest to join a Community Waste Reference Group (**CWRG**) with a focus on waste reduction and recycling opportunities. The CWRG is intended to help MASC facilitate meaningful engagement with the wider community to inform and deliver future waste management services.

Please note that the CWRG is not intended to consist of representatives from existing agencies, organisations and groups etc. MASC will be liaising with interested groups separately.

What is the future of waste management in Mount Alexander Shire?

Community input is being sought to help guide the future of waste management in the Shire. Specifically, input is required in relation to the priorities identified below.

Priority 1 - Waste reduction and recycling opportunities

The Victorian government has stated that by 2030 all councils in Victoria will have to meet certain objectives in relation to how commingled recyclables, glass and food organics and garden organics (FOGO) waste is collected and processed. This is described within the State Government's 'Recycling Victoria - A new economy' policy dated February 2020.

Key objectives of the CWRG will be to work through solutions in relation to:

- the separation of glass and FOGO waste aligned with the State Government policy.
- options to maximise a local circular economy including within our business community.
- Waste education and communication.

Priority 2 – Development of a Resource Recovery Centre

With the end of landfilling operations at the Castlemaine Waste Facility site, we are about to commence planning for a Resource Recovery Centre (RRC) on the site. We are looking for community ideas on how to make the facility something that is useful, valuable and affordable for the Shire.

Key objectives of the CWRG in relation to the RRC include:

- review, development and confirmation of the preferred functions and opportunities to be achieved through a well-designed RRC
- development of a design brief
- participation in design reviews, as well as review and comment on design documents, and
- engagement with and advocacy to the community in relation to the design

Council will be requested to consider the project at relevant milestones, and for approval once the final design and construction cost estimate is determined.

Construction of the RRC will be subject to Council and State government authority approvals, and funding availability. Pending timely progress of the design process, construction could commence in FY2022/23.

What is a Community Waste Reference Group?

This CWRG is designed to be a deliberative form of community engagement. MASC will coordinate the group, and selected members will have the opportunity to participate in a structured forum, acting as advisors and representatives of the wider community.

While the CWRG does not hold decision-making power (as this function sits with MASC), the benefits of a CWRG include:

- Providing a forum for members to discuss issues of community interest and influence outcomes for the benefit of the community in relation to project objectives.
- Drawing on local knowledge and enhanced community voice in decision making processes and outcomes.
- Building community understanding of Council's core business functions and specific projects.

The membership of this CWRG is intended to be made up of a variety of community members from various locations within the Shire across a broad age range. Members will be a diverse mix of representatives and will represent a cross section of people with different skills and backgrounds. Experience in development of infrastructure is not essential. There will also be a cross section of MASC representatives and appointed specialist consultants involved in the various milestones in the project.

Membership on this CWRG is voluntary. During the application process, applicants will be provided with opportunities to advise of any support needs such as accessibility and language.

How to apply

Interested community members are encouraged to complete the EOI application below to be considered for membership in the group. The applications will be assessed based on the eligibility and assessment criteria by a panel comprised of MASC's Waste Coordinator, Waste Management Officer, and Executive Manager Infrastructure, with approval of the successful applicants referred to Director Infrastructure and Development.

Assessment Criteria

Selection criteria

Applicants for the CWRG must, as part of their EOI application, respond to four questions relating to their interest in becoming a member of CWRG and their current involvement and/or activity in the local community.

Responses to these four questions will be scored (out of 4) on the following basis:

Response	Score
No or low level of interest and participation. No relevant examples provided.	1
Interest and participation demonstrated. Limited detail of relevant experiences and examples provided.	2
High level of interest and participation. Relevant examples and experiences outlined.	3
High level of interest and participation including detailed and relevant examples and experiences. Experiences, knowledge and insights linked to the groups' stated objectives.	4

Representativeness

As much as is possible, Council seeks to ensure that members of its CWRG are representative of the diversity of demographics within the Mount Alexander Shire community. The following demographics will be reviewed with a view to ensuring appropriate representativeness:

- Age
- Gender
- Background (for example LGBTQI, CALD, Disability groups, Indigenous and Torres Strait Islanders); and
- Geography of the Mount Alexander Shire Local Government Area.
