Class 1	An application for a use of the land only (i.e. includes liquor licence, car parking reduction or waiver, place of assembly and other uses)	\$ 1,318.10	\$ 1,318.10
Class 2 Amendment	An application to change or allow a new use of the land Amendment to change the statement of what the permit allows; or change any or all conditions (other than a permit to develop land or use and develop land or undertake development ancillary to the use of land for a single dwelling per lot.) #### Single Dwelling Permit Applications

To develop land for a single dwelling per lot, or use and develop land for a single dwelling per lot, tree removal associated with a single dwelling, and to undertake development ancillary to the use of land for a single dwelling per lot included in the application (other than a VicSmart Application or a permit to subdivide or consolidate land) if the estimated cost of development

#### TO AMEND A PERMIT APPLICATION AFTER NOTICE HAS BEEN GIVEN

Regulation	Type of Application	Fee
12	Amend a permit application after notice (advertising to neighbours) has been given, but before decision; or Amend an application for a permit or amend an application to amend a permit after notice has been given	40% of the application fee plus difference if application changes to the next class
